

12 Days of Christmas with the Columbia Falls Area Chamber Official Rules

1. Sponsors. This charitable raffle drawing is sponsored by Columbia Falls Area Chamber of Commerce: 233 13th Street East, Pox 312 Columbia Falls, MT 59912. The Chamber may be contacted at director@columbiafallschamber.org or by calling 406-892-2072.

2. Prizes. Prizes will be drawn the first 12 days of December.

December 1st: 12 prizes, December 2nd: 11 prizes, December 3rd: 10 prizes
December 4th: 9 prizes, December 5th: 8 prizes, December 6th: 7 prizes
December 7th: 6 prizes, December 8th: 5 prizes, December 9th: 4 prizes
December 10th: 3 prizes, December 11th: 2 prizes
December 12th: 1 prize (\$250 in Christmas Cash)

78 prizes in total will be drawn. The Prizes are not transferable and the winner has no right of substitution (in cash or otherwise).

3. Eligibility. Open to residents living in the State of Montana who are at least 21 years of age at the time of submission of the entry ticket(s).

- How to Enter. Enter from 8:00am November 1st– 5:00pm November 30th, 2017
 - Call 406-892-2072 to purchase over the phone
 - Write a check payable to “Columbia Falls Area Chamber of Commerce”
 - At any Chamber event
 - Purchased from any Chamber board member
 - Every participant is able to receive 1 ticket free of cost. To receive your free ticket, send a self-addressed envelope to Columbia Falls Area Chamber, Box 312 Columbia Falls, MT 59912. Must be postmarked by November 30th to be included in the drawing.

The Chamber accepts cash, credit cards, and checks.

4. How a Winner will be Selected. 78 winners will be selected in a random drawing from among all eligible entries received during the month of November.

5. Odds of Winning. The odds of winning one of the 78 prizes depends on the

number of eligible entries received during the Entry Period. If a person enters the drawing more than once, they are allowed to win if their name is drawn multiple times throughout the course of the raffle.

6. Conditions of Participation. Each person who enters into the 12 Days of Christmas Charitable Raffle (“Entrant”) agrees to be bound by these Official Rules, the rules of any website or social media platform used in conjunction with the raffle, and all decisions of the Sponsors, whose decisions will be final.

If, for any reason, the fairness or integrity of the raffle becomes compromised, or the Sponsors’ administration or fulfillment of the raffle becomes impracticable, Sponsors reserve the right to terminate or modify the raffle. Sponsors further reserve the right to disqualify any individual who does not comply with the Official Rules, makes a misrepresentation on his or her entry form, makes a misrepresentation or material omission in any other information provided to Sponsors in connection with the raffle, or tampers with the entry process, an entry form, or the administration of the raffle.

If a Prize Winner does not respond to notification within fourteen (14) days, is found to be ineligible, fails to execute the Affidavit or other documentation required by Sponsors, and/or the Prize is returned as undeliverable, Sponsors may consider such Prize Winner to have forfeited the Prize, and another Prize Winner may be selected. The Prize will be awarded within approximately thirty (30) days of the winner’s complete response to notification.

Sponsors will coordinate delivery and/or pick up of Prizes to winners. All other costs, taxes, fees, and expenses associated with a prize, or the acceptance and use of any element of a prize not specifically addressed above, are the sole responsibility of the winner.
